Requirements for the publication

1. Article metadata:

- full title of the article:
- full name of the author (if there are several authors, then information is given for each author);
 - academic title, academic degree, position;
 - place of work: department, faculty, name of the university;
 - city, country;

- work address with zip code;
- work phone number;
- e-mail;
- grant information (if available).

2. Technical requirements for the text.

- The recommended volume of the text as a whole, including all structural parts is at least 20,000 printed characters (including spaces). Times New Roman font, single spacing, 14 size, paragraph 1.25 automatically set. All margins are 2 cm each; width alignment; portrait sheet orientation.
 - The word limit for the abstract is 200-250.
- The minimum percentage of uniqueness according to the Anti-Plagiarism system is at least 85%.
- Tables are placed in the text of a scientific article indicating the numbering and references to the numbered table in the text. Each table should have a title and an indication: "compiled by the author, by the authors".
- **3. Structure of the article.** The text should be divided into parts, the headings should be signed:

Introduction.

Materials and methods.

Results.

Discussion.

Conclusions.

References.

Requirements for the references

The total number of sources is 15-20, while at least 50% of them must be foreign. At least 30% of the sources must have been published within the last 5 years. The references are placed at the end of the article in alphabetical order.

When specifying sources, a full description of information about the author, the place and time of publication, full data about the journal and other publication format is required: the author's first and last name, the year of publication, the title of the article, the title of the journal, volume / number / issue, pages.

If the source is electronic, an active link to the material with an access code is indicated in the list of references.

For sources in English:

COMMENTS FOR AUTHORS ON THE ARTICLE STRUCTURE

- 1. The title of the article. In the title, it is preferable to use the main key concepts (words) of the publication topic, the title should include no more than 10-14 words (including conjunctions), the use of abbreviations (except for permissible international ones) is prohibited in the title.
- **2. Abstract.** Abstract structure: a brief description of the research objectives, methods, research material, results achieved, brief conclusions (possible indication of practical application). The volume is 200-250 words.

This article discusses the problem...

The article is devoted to the phenomenon...

Special attention is paid to...

The article analyzes...

The author focuses the main attention in the work on...

The characteristic features are highlighted and described...

- **3. Keywords.** The number of keywords is from 5 to 10. Keywords should reflect the topic, material, scientific field, object and subject of study. Recommendations:
 - basic (commonly used) terms should be used;
 - polysyllabic words and constructions should be avoided.
 - 4. **Introduction.** The following items should be present in the Introduction:
- a brief description of the purpose of the study, the topic of the study and the scope of application;
- literature review, where it is required to indicate general research trends in the chosen field, existing contradictions in theory, methodology, practice or research conclusions, "white spots" in research or scientific schools, prospects for the development of the topic; the latest academic sources (possible reference to them or citation);
- the position of the author (justification of the criteria that were applied for the analysis and selection of literature, research material, methods of analysis);
 - confirmation of the relevance of the study;
- author's achievements reflected in the article: filling gaps in science and practice; using new data; developing a new methodology, etc.

- 5. **Materials and methods.** For theoretical research, it is recommended to substantiate and describe the methodology that was used to obtain the results, and the specific methods used in the work. **For experimental studies**, it is necessary, among other things, to give a detailed description of the experiment, methods and equipment that were used.
- 6. **Results.** Review of all the results of the study. The general requirement is clarity and consistency of presentation, the use of general phrases should be avoided; **the results should correspond to the stated goals and objectives of the article**; it is necessary to clearly describe the conclusion, idea, concept or method that the author came to as a result of the research. In this section, you should minimize the use of sources and focus on your own observations and results.
- **7. Discussion of the results** is the main part of the article. The analysis and explanation of the course of the research and its results are carried out, and the place of the results obtained during the research in scientific theory and practice is determined. It is necessary to compare the results obtained in the article with the results of research by other authors. Having considered other scientific concepts, determine the initial positions, the essence of the research and the results obtained. It should also reflect the assessment of the reliability of the results obtained and their comparison with other people's existing results. The volume of the section is 4-5 pages of printed text.
- **8. Conclusions.** The results that were explained in the discussion are presented in a concise and systematic form. Conclusions should be a concise description of the main part of the article. The main task of the conclusions is systematization. It indicates the practical and scientific value of the study, possible areas of application, and the prospect of research. This is a summary of the work done, a key conclusion or a list of the main conclusions.
- **9. References**. The list must contain at least 15 sources (including sources of factual material), of which at least 50% are in a foreign language. It is recommended to use at least 30% of current works (published in the last 5 years). The advantage will be the use of articles published in the Scopus and Web of Science databases over the past 5 years.
